### Instructions to order search

To order a Rhode Island Statewide (BCI) report, please follow these instructions:

1. Order the Rhode Island Statewide (BCI) online through your NCS account.
2. Complete the form on the next page for the Rhode Island Statewide (BCI) request.
3. Mail the completed and notarized form to NCS.
  - a. NOTE: Copy of photo identification with date of birth must accompany this Disclaimer. Acceptable documents are 1) State Issued Driver's License, 2) State Issued Identification Card, OR 3) Passport.

The results will be uploaded to your online account and an e-mail will be sent to you as soon as the results are available. Turnaround is 20 business days from the time we receive the form and photo ID.
